> Sub: Extension of approval of affiliation of Swami Shukdevanand Law College, Shahjahanpur, U.P. for imparting three year LLB course as well as five year BA LLB course.

Sir,

The Bar Council of India at its meeting held on 23rd August, 2014 considered the inspection report of the above mentioned college. After consideration the Council decided as follows: -

> The Bar Council of India considered the inspection report submitted by the inspection team. After consideration, Council is of the view that Swami Shukdevanand Law College, Shahjahanpur, UP be granted extension of approval of affiliation for running three year LL.B course with existing strength of five sections of 60 students in each section and for five year BA LL.B course with one more additional section of 60 students along with existing strength of two sections of 60 students i.e. total three sections of 60 students in each section for a period of six years since they have applied two times with requisite inspection fee i.e. for the academic years 2011-2012, 2012-2013, 2013-2014, 2014-2015, 2015-2016 and 2016-2017 subject to the following conditions.

So far additional sections granted now to three year LLB and five year BA.LLB will be effect from the year 2014-15.

- The college management is directed to establish the Legal Aid Centre as per Clause-11, Schedule-III of Rule-11 of the Part-IV of the Legal Education Rules - 2008,
- College should ensure the payment of salary to teachers as per 2. Rules 22 schedule III, Part IV of BCI Rules.
- The college is directed to upgrade the library by investing minimum Rs. 1,00,000/- per year per stream.
- Teacher Student ratio shall be as per Schedule-III, Rule-11, Clause-17, Part-IV of Bar Council of India Rules.

Further, it is found that in the list of faculty members at Sr. No. 20 to 24 they are not qualified as they are having only LL.B degree. Hence, they cannot take classes. For this, report should be submitted by the college.

Further, the books in the library seem to be very little. As per the rules of the Bar Council of India minimum requirement for library is hereunder. The college must follow this rule and invest minimum Rs. One lakh if the college runs both the streams. The relevant Rule 15 of Schedule III of Legal Education Rules 2008 is given below: -

"Minimum Library requirement: To start with, a Law Library shall have a set of AIR manual, Central Acts and Local Acts, Criminal law journal, SCC, Corporate Law Advisor, Company cases, Indian Bar Review, selected Judgements on Professional Ethics and Journals with the back volumes for at least ten years and also such number of text books in each subjects taught during the period according to the minimum standard ratio of ten books for each registered students. For running integrated program, text books of such other subjects are also to be kept in the similar minimum ratio. The minimum investment in Library in each academic year shall be Rupees Fifty thousand for one stream and Rupees One Lakh for both the streams."

Further, the college should also maintain the timing which has to be minimum 5 1/2 hours with half an hour break. College to file an affidavit to the Bar Council of India within six weeks mentioning the timing of the classes. The relevant rules are quoted hereunder: -

### Rule (xxiii), Chapter I

"(xxiii) "Regular Course of Study" means and includes a course which runs for at least five hours a day continuously with an additional half an hour recess every day and running not less than thirty hours of working schedule per week."

## Rule 5 of Schedule III

"Classes may be conducted between 8 a.m. to 7 p.m. in an Centre of Legal Education, which is not fully residential. However the Library may remain open till 10 p.m."

Institution should submit affidavit in compliance to the above conditions within six weeks.

College authorities are also required to apply to the Bar Council of India for further extension of approval six months in advance before expiry of the period of approval of affiliation granted by the Bar Council of India i.e. on or before 31st December, 2016 failing which a late fee will be charged.
